- Anticipate receiving new materials from Ethan via Governor Justin.

Comments from DA Trecate

- Emphasize commitment to service agreements, despite other commitments --> prioritize Key Club alongside health and family obligations.
- However, there is assurance of flexibility and willingness to work through
 conflicts if communicated promptly.
- Acknowledge the demanding nature of the role, requiring perseverance and grit. The role of LTG is a difficult one, but it is a great propeller forward into the future.
- Remember the availability of support and commitment to helping each other through the year.
- Make new board members aware of the financial cost of board meetings, with a breakdown provided in the district budget.
- Understand that funding sourced from dues, making absenteeism costly for clubs and members.

Important Events

- Committee forms and directives: Instructions provided.
- Regional Training Conferences: Workshops and presentations.
- Fall Rally: Encouraged to progress on work during summer.
- ICON in Atlanta: Accommodation at Kings Dominion in Pennsylvania, activities in Atlanta including visits to museums and aquarium. Board subsidies available. Roughly \$950-1,200 for the full week plus room and board.
 January Onward meetings: Bi-monthly, typically in person.
- Longer 2025 Midwinter meeting at a different location for enhanced professionalism and training.
- DECON: Possibly at Asbury Park with plans for a more enjoyable and expanded event. First weekend in April; two nights-- Thurs-Sat.

Advice for Lieutenant Governors

- Start early: Initiate early communication with clubs regarding upcoming elections and contacts.
- Letters of Introduction: Share drafts with ZA, Ms. Trecate, and Gov. Chen, and distribute to clubs within the next few weeks.
- Newsletters: Begin planning newsletters, focusing on a theme, and distribute as PDFs. Utilize Key Club email for all communications. Newsletters due by the 10th of each month, highlighting DECON and including photos. Early submissions may receive feedback.
- Obtain slideshow from the Midwinter training conference, contact Secretary
